

**2022 “PEPSI® THE TASTE OF YOUR TEXAS T-SHIRT INSTANT WIN GAME”
 (“PROMOTION”)
 OFFICIAL RULES**

NO PURCHASE NECESSARY TO PLAY OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. INTERNET REQUIRED. STANDARD DATA RATES MAY APPLY IF USING A MOBILE DEVICE.

ONLY OPEN TO LEGAL RESIDENTS OF THE U.S. WHO, AT THE TIME OF ENTRY AND PRIZE AWARDING, ARE 18 YEARS OF AGE OR OLDER AND RESIDING IN TEXAS.

1. PROMOTION PERIOD: Entry into the Promotion begins at 9:00:00 a.m. Central Time (“CT”) on June 6, 2022 and ends at 11:59:59 p.m. CT on July 31, 2022 (“Promotion Period”).

2. HOW TO PARTICIPATE: During the Promotion Period, there are two ways to play for a chance to win:

- a. Code: Scan the code found on the Pepsi Taste of Your Texas T-shirt signage at participating restaurants, which will automatically take you to www.pepsipromos.com/txtshirt (“Website”) to play the game.
- b. Website: No Purchase Necessary Visit the Website (www.pepsipromos.com/txtshirt) and follow the directions.

Regardless of how you get to the Website (via code or visiting the Website directly), once you arrive, follow the on-screen registration instructions. Once you have provided the required information click “ENTER” to submit a Game Play and see if you are a potential instant winner. All Game Plays must be submitted by 11:59:59 p.m. CT on 7/31/2022. Results of Game Plays are randomly determined and are not based on actual game playing or skill.

Limit one (1) Game Play per person, per email address and per household each day during the Promotion Period, regardless of method of Game Play. A “day” is defined as a twenty-four (24) hour time period beginning at 12:00:00 a.m. CT and ending at 11:59:59 p.m. CT; except for the first day of the Promotion Period which will be from 9:00:00 a.m. CT and ending at 11:59:59 p.m. CT. The time clock of the Promotion Administrator is the official clock for this Promotion.

By registering for the Promotion and submitting a Game Play, entrants fully and unconditionally agree to be bound by these Official Rules and the decisions of Sponsor and its appointed agents, which will be final and binding in all matters relating to the Promotion. In the event of dispute over the identity of a potential winner, a Game Play will be declared made by the authorized account holder of such email address or

wireless phone number submitted at the time of Game Play, and potential winner may be required to provide identification sufficient to show that they are the authorized account holder of such email address or wireless phone number.

Each Game Play must be manually keystroked and manually entered by the individual participants; automated and/or repetitive electronic Game Plays (including but not limited to Game Plays made using any script, macro, bot or promotion service) will be disqualified and transmissions from these or related email/IP addresses or wireless phone number may be blocked.

3. 5. WINNER SELECTION, VERIFICATION AND ODDS: Six hundred fifty-six (656) prizes will be available to be won. Prizes are redeemable only by clicking and following the directions via the valid link provided at the time of Instant Prize Notification. **In the event that the potential winner does not click on the valid link within 10 minutes to claim their prize, their prize will be forfeited, and no compensation will be given.**

Sponsor reserves the right at its sole discretion to disqualify any individual found to be tampering with the entry process or the operation of the Promotion or any website; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person.

LIMITATIONS OF LIABILITY: Sponsor and Promotion Parties, along with each of their parent, subsidiary and affiliated companies, and all of their employees, officers, directors, agents, contractors, prize suppliers, promotion/advertising/fulfillment agencies associated with this Sweepstakes (collectively the "Released Parties"), assume no responsibility or liability for (a) any incorrect or inaccurate entry information, or for any faulty, incomplete or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Promotion; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Promotion; (d) inaccessibility or unavailability of the Internet or the Website or cellular phone service or any combination thereof; (e) any injury or damage to participants or to any other person's computer or mobile device which may be related to or resulting from any attempt to participate in the Promotion or download of any materials in the Promotion, whether caused by Sponsor, users or by any of the equipment or programming associated with or utilized in the Promotion or by any technical or human error which may occur in the processing of submissions which may limit a participant's ability to participate in the Promotion. In such event, Sponsor shall immediately suspend all drawings and prize awards, and Sponsor reserves the right to award any remaining prizes (up to the total set forth in these Official Rules) in a manner deemed random fair and equitable by Sponsor, such as by way of example and not by way of limitation, in a random drawing from among all eligible, non-suspect Game Plays received up to the time of the impairment, and Sponsor shall not have any further liability to any participant in connection with the Promotion.

If for any reason the Promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorized intervention, automated plays, fraud, technical failure, human error, or any other cause beyond the control of Sponsor that corrupts or affects the administration, security, fairness, integrity, or proper conduct of the Promotion, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the Game Play process and to cancel, terminate, modify, or suspend the Promotion, and Sponsor and the other Released Parties assume no responsibility for any error, omission, interruption, telephone or other communications malfunctions, deletion, defect, delay in operation or transmission, communications line failure, or theft or destruction of, unauthorized access to, or alteration of entries. Sponsor and other Released Parties are not responsible for any problems or technical malfunctions of any telephone networks or lines, computer online systems, servers, or providers, computer equipment, software, failure of any email or Game Play to be received by Sponsor or its agents/representatives on account of technical problems or traffic congestion on the Internet or at any website, any combination thereof, or otherwise, including any injury or damage to participant's or any other person's mobile device or computer related to, or resulting from, participation or downloading of any materials in the Promotion.

In no event will Sponsor be obligated to award more prizes than the number of prizes stated in these Official Rules.
