

LIPTON® GRILL WITH T SWEEPSTAKES

OFFICIAL RULES

1. SWEEPSTAKES PERIOD: Entry into the Lipton® Grill with T Sweepstakes (the "Sweepstakes") begins at 12:00 a.m. Eastern Time ("ET") on July 11, 2021 and ends at 11:59:59 p.m. ET on September 18, 2021 ("Sweepstakes Period").

2. ELIGIBILITY: You must be a legal resident of the United States who, at the time of entry and prize awarding, is residing in Alabama, Arkansas, Florida, Georgia, Illinois, Indiana, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, Ohio, South Carolina, Tennessee, Texas, Virginia, West Virginia or the District of Columbia and is 18 years of age or older (19 or older in Alabama). (b) INTERNET: Visit www.GrillWithT.com (the "Website") and follow the on-screen instructions to properly complete and submit an online entry.

Limit one (1) entry per day per person/email address/phone number, regardless of entry method. If more than one entry is received from the same person/email address/phone number in one day, all but the first entry may be disqualified. A "day" is defined as a twenty-four (24) hour time period beginning at 12:00:00 a.m. (midnight) ET and ending at 11:59:59 p.m. ET, other than the

first day of the Sweepstakes if the Sweepstakes begins at any time other than 12:00 a.m., in which case the first day begins at the start time stated time in Rule 1. The time clock of the Sweepstakes administrator is the official clock for this Sweepstakes.

In the event of a dispute over the identity of a potential winner, an online or text message entry will be declared made by the authorized account holder of such email address or wireless phone number submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address or wireless phone number. All parties will be required to follow city restrictions for COVID-19 and sign a Covid Protocol Agreement. All eligible entrants will be given access to a Spotify Playlist code upon completing registration for the Sweepstakes. Eligible entrants will be shown a link that directs entrant to the Spotify homepage. Upon signing in or signing up for a free Spotify account, entrants will be directed to a Grilling With T Lipton playlist. The playlist will be available for the Sweepstakes Period.

5. **DRAWING:** Two potential winners will be selected from the eligible entries received during the Sweepstakes Period. Winners will be selected started with the highest value prize and moving to the lower value prize(s). Odds of winning depend upon the number of eligible entries received during the Sweepstakes Period. Limit one (1) prize per person/address/phone number/household during the entire Sweepstakes. All prizes claimed will be awarded. Unclaimed prizes may not be awarded.

6. **WINNER NOTIFICATION:** Depending on the entry method used, potential winners will be notified by text or email at the phone number or email address provided upon entry, within approximately one (1) days of the drawing ("Winner Notification").
