

MTN DEW® “BAJA YOUR RIDE” SWEEPSTAKES AT SPEEDWAY®

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING. INTERNET ACCESS REQUIRED. MULTIPLE ENTRY DEADLINES APPLY.

The Mtn Dew® “Baja Your Ride” Sweepstakes at Speedway (the “Promotion”) is sponsored by Pepsi-Cola Company (“Sponsor”), 1111 Westchester Avenue, White Plains, NY 10604.

1. PROMOTION PERIOD: The Promotion begins on June 14, 2021 at 12:00:00 AM Eastern Time (“ET”) and ends on August 15, 2021 at 11:59:59 PM ET (“Promotion Period”) and consists of one hundred eight-nine (189) Daily Prizes and one (1) Grand Prize, as defined in Section 4. Administrator’s clock shall be the official clock of the Promotion. A “day” begins at 12:00:00 A.M. ET and ends at 11:59:59 P.M. ET during the Promotion Period.

2. ELIGIBILITY: This Promotion is open to legal U.S. residents of Alabama, Arizona, California, Colorado, Connecticut, Delaware, Florida, Georgia, Illinois, Indiana Kentucky, Massachusetts, Michigan, Minnesota, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina Ohio, Pennsylvania, Rhodes Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, Wisconsin or West Virginia who are at least 18 years of age (19 in AL). Follow the prompts and instructions to register for or log-in to an account. Entrants will be required to provide their First & Last Name, valid Email Address, Mailing Address, Zip Code, Phone Number and Date of Birth to register. Once registered and logged in, entrant will be prompted to scan their qualifying Mtn Dew 20oz bottle with phone, laptop or desktop camera in order to receive an entry (“Daily Entry”).

B. Play without purchase: Visit pepsipromos.com/baja-your-ride and follow the prompts to enter email. A unique url link will be sent via the email address provided. Via this link, follow the prompts and instructions to register for or log-in to an account. Entrants will be required to

provide their First & Last Name, valid Email Address, Mailing Address, Zip Code, Phone Number and Date of Birth to register. Once registered and logged in, follow the prompts to receive an entry for the day in which the entrant logged into their account (also a “Daily Entry”).

Limit of one (1) Daily Entry per person/email address/IP address/ mailing address per day.

4. HOW TO ENTER INTO THE GRAND PRIZE DRAWING: Each valid Daily Entry will automatically give the entrant one (1) entry into the Grand Prize Drawing.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
