

**MTN DEW® “CHARGE YOUR GARAGE” INSTANT WIN GAME & SWEEPSTAKES AT
SPEEDWAY®**

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING. INTERNET ACCESS REQUIRED.

The Mtn Dew® & Speedway “Charge Your Garage” Instant Win Game & Sweepstakes (the “Promotion”) is sponsored by Pepsi-Cola Company (“Sponsor”), 1111 Westchester Avenue, White Plains, NY 10604.

1. PROMOTION PERIOD: The Promotion begins on March 1, 2021 at 12:00:00 AM Eastern Time (“ET”) and ends on May 2, 2021 at 11:59:59 PM ET (“Promotion Period”) and consists of one thousand sixty-seven (1,067) Instant Win Prizes and one (1) Grand Prize, as defined in Section 4. Administrator’s clock shall be the official clock of the Game. A “day” begins at 12:00:00 A.M. ET and ends at 11:59:59 P.M. ET during the Promotion Period.

2. ELIGIBILITY: This Promotion is open to legal residents of the fifty (50) United States and the District of Columbia who are at least 18 years of age and are of the legal age of majority in their state of residence at the time of entry (19 in Alabama and Nebraska, 18 in all other locations). Employees of Sponsor, Speedway LLC, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, “Promotion Entities”) and each of their immediate family members (e.g., spouse, parent, child, sibling, and their respective spouses and the “steps” of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All federal, state, and local laws apply. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Promotion. Purchase any Mtn Dew 20oz bottle (*qualifying products include Mtn Dew®, Diet Mtn Dew®, Mtn Dew® Zero Sugar, Mtn Dew® Code Red, Mtn Dew® Diet Code Red, Mtn Dew® Livewire, Mtn Dew® Real Sugar, Mtn Dew® Voltage, and Mtn Dew® Major Melon or Mtn Dew® Major Melon Zero Sugar*) and visit YearOfDew.com/charge-your-garage during the Promotion Period. Follow the prompts and instructions to register for or log-in to an account. Entrants will be required to provide their First & Last Name, valid Email Address, Mailing Address, Zip Code and Date of Birth to register. Once registered and logged in, entrant will be prompted to scan their qualifying Mtn Dew 20oz bottle in order to complete a Game Play. If entrant has won an Instant Win Prize, they will be notified automatically via a winning message on the screen, followed by an email notification.

B. Play without purchase: Visit pepsipromos.com/charge-your-garage and follow the prompts to enter email. A unique url link will be sent via the email address provided. Via this link, follow the prompts and instructions to register for or log-in to an account. Entrants will be required to provide their First & Last Name, valid Email Address, Mailing Address, Zip Code and Date of Birth to register. Once registered and logged in, follow prompts for completing a Game Play. If Entrant has won an Instant Win Prize, they will be notified automatically via a winning message on the screen, followed by an email notification.

Limit of one (1) Game Play per person/email address/IP address/ mailing address per day.

4. HOW TO ENTER INTO THE GRAND PRIZE DRAWING: There are two (2) ways to enter into the Grand Prize Drawing:

A. Complete a Game Play, as described in Section 3. Each completed Game Play will result in one (1) entry into the Grand Prize Drawing.

Registration for and use of Instagram are subject to Instagram’s respective terms and conditions and Sponsor has no responsibility with respect to such registration or use or enforcement of such terms and conditions.

During the Promotion Period, capture a photo or video demonstrating how you are a fan of the Year of DEW and post it on your Instagram Newsfeed, using the hashtags #YearOfDew and #Sweepstakes. Instagram Stories and posts without these hashtags will not qualify. Each post is one (1) entry into the Grand Prize Drawing. The name of the person submitting an Entry into the Sweepstakes must be the name of the authorized account holder of the social media account, otherwise, an entry may be deemed void. In the event of a dispute over the identity of a potential winner, entries will be declared made by the authorized account holder of the social media account, and the potential winner may be required to provide identification sufficient to show that they are the authorized account holder. It is solely the responsibility of the entrant to notify the Sponsor in writing if the entrant changes their Instagram account used to enter the Sweepstakes during the Promotion Period

5. PRIZES:

A. Instant Win Prizes: There are one thousand sixty-seven (1,067) Instant Win Prizes available*. Limit one (1) Instant Win Prize per person/email address/IP address/ mailing address throughout Promotion Period. Instant Win Prizes and their Approximate Retail Values (“ARV”) are listed below.

*There will be 1,067 random, computer generated winning times during the Promotion Period. If you are the first player to play the Game at or after one of the randomly-generated times, you will be a potential winner of the Instant Win Prize indicated (subject to verification). The odds of winning an Instant Win Prize depend on the timing of each entrant's completed Game play in relation to the randomly generated times, and the quantity of Instant Win Prizes available at the time of Game play.

B. Grand Prize: One (1) Grand Prize will be awarded during the Promotion Period. The Grand Prize consists of one (1) 2021 Dodge Durango of the winner's choosing with a Manufacturer Suggested Retail Price ("MSRP") not to exceed \$66,000 (inclusive of \$1,495 destination and handling); however, if options are selected with an MSRP of less than \$66,000, winner will NOT receive the difference in prize value and ten thousand dollars (\$10,000), awarded in the form of a check made out in the winner's name to assist with any incidental costs and fees.
